Event Overview

The ALLA is a professional body with the following objectives:

- To address issues which affect the profession nationally;
- To act as a lobby group to promote the interests of law libraries, law collections, legal information services and associated staff, in the wider community;
- To communicate to members of the Association as a whole; to liaise with member Divisions; to disseminate information among Divisions; and to foster a spirit of co-operation among members of the profession;
- To benefit members and enhance the status of the profession by the further education and training of law librarians, legal information officers, and others through the organisation of meetings and conferences; the publication of information of interest to members; and the encouragement of bibliographical study and research in law and law librarianship;
- To promote co-operation with relevant other organisations or societies.

Attendance at the national conference attracts many professionals in the law library sector, including private, government, academic, courts and corporate sectors.

The national conference is widely promoted throughout Australia and internationally with presenters of high quality.



Theme

The theme for the 2012 national conference is *Respect the past. Embrace the future.*

We are in the midst of a global information revolution that is transforming not just the availability and accessibility of legal information but the very nature of that information. The challenge during any period of rapid change is to recognise that it is part of a continuum and that by connecting with the past we can ensure a better future.

The international law library community continues to debate the practical use of eBooks, the need to collect print law reports, the use of technology in court rooms, the value of authorised law reports and the necessity of authorising online legislation. As baby boomers move into retirement and the profession adopts new paradigms in librarianship, technology, service standards and publishing, divergent ideas of best practice often result.

The conference theme encourages law library professionals to reflect on the value of law librarianship traditions and the rigorous standards on which they are based while exploring the best of what our 21st century environment offers modern practice.

Location


Door Prizes
